## Bill promotes funding for group mental homes

At the first lobbyist meeting of the week on Sunday, Andrew Edwins 0161, the senator from McKneally County, brought a bill from his home town that his family has been pushing for a while.

The bill targets funding for group mental health Homes, and their funding. The lobbyists were beginning their attempt to muster support for the bill
because it offers funding based upon the individual population and needs of homes. Currently the funding is standardized and every one of the homes gets the same funding, which causes problems for those homes that have greater need for funding and staff.

Many homes have overcrowding issues, and lack enough staff members to effectively care for the residents. Volunteers are heavily relied upon for their transportation needs because they simply do not have the staff necessary.

Edwins' family has been pushing this bill known, as Eddie's Bill, for more than a decade. The bill will hopefully rectify the funding issues, and allow for some homes to increase their maximum tolerable population. Eddie is the name of Edwins' uncle.

His uncle has a mental disability; he is also deaf. He had been living with his parent, Andrew's grandparents, which was very difficult for them. Eventually it became to overbearing and they tried
to put him into a group home for the mentally disabled.

He was placed onto a waiting list, for over two years. After his two-year waiting period he was finally granted an interview for the home. He was allowed to reside in the home where the family quickly began to see the issues within the homes. This case has also been repeated for many other families across the country.

The lobbyists are continuing in their attempt to muster support, and assuming the bill moves on from the lobbyists, it will move on to the Senators, for them to vote.

The bill is a good idea, in my personal opinion because it will allow for group homes to better provide care to the disabled. Funding is a major issue with today's economy, and the well-being of the people should not be something of major issue. More support for the bill, however, is necessary for it to be approved.

Citizens of Boys State kicked-off their respective party caucuses Saturday night. The Nationalist Party in particular had a very long night. Going into an astounding fifth vote for their respective party chairman, it soon became clear which individuals chose to serve in capacities that reflect their skills and passions and will one day lead our great nation!

Boys' State Councilor Robert Yosh said, "Everything in politics is a learning experience. In here you learn every vote counts; this is part of the Boys' State Miracle!" On Saturday evening, some 450 Boys' Staters crowded into the sizzling Recreation Center to gavel in the Federalist Party convention. Beginning with an accounting of the voting strength of each county, the convention leisurely proceeded to the election of the Party Clerk.

To many in the Roosevelt County, County Counselor Dave Downey is a respected man and is known for leading his counties to success. In fact, Mr. Downey has volunteered his time at Boy's State for 15 years. During those 15 years Mr. Downey, has earned a reputation of being one of the most prestigious and elite County Counselors to ever step foot on a Boy's State Campus.

One does not receive this title for simply volunteering; Mr. Downey has won multiple "\#1 County Awards." When asked about this, Downey responded, "Without good counties, you will never win an award."

However, our recent guest speaker, District Attorney Scott McNamara, would not agree with the tactics that may have been used to achieve these awards.

It has been brought to the attention of the news room, along with many other Boys' Staters, that Mr. Downey may have been encouraging "Block Voting" among counties to push candidates through. When asked about this accusations Downey claimed that he teaches the opposite idea to his citizens.

In addition to this reply, he also was quoted in saying, "If you look at Roosevelt's voting record, this is shown." However, when asked what he would do if he noticed this "Block Voting" occurring during elections, Downey replied, "I would not respond."

This race established the scheme of all future convention elections, as following the initial round of all nominees from all counties, the top five candidates preceded to a second round, and then to a run-off of the top three candidates.

If there was no absolute majority achieved, the top two candidates woud proceed to a final round, which ended up being the case for the Party Chairman and Comptroller nominations. This was avoided in the first race of the convention, that for the aforementioned position of Party Clerk, which was won by William Borkowski 0342 from Fish County by an overwhelming margin of 324 to 121 votes.

Throughout the convention, it was noted by many Citizens and observers that unfortunately block voting seemed to monopolize the convention, with Fish County carrying out the practice rather regularly.

The race for Party Secretary was among the most divisive, yet ended with the ultimate win by the nominee from Wong County, Michael Signorile 0680 , by a margin of $246-198$ votes.

The evening's drama was provided by an upset in the race for Permanent Party Chair, as the winner of the three-person run-off, 0006 from Roosevelt County, "Jake From State Farm" (Davis) failed to win the final runoff against the nominee from Pedro County, Connor Moran 0782, by a 264-183 margin.

On Sunday, the county parties caucused to nominate appointees for State office, and all reports pointed to strong interest in the gubernatorial race. In the second session of the convention, the Federalists elected their slate of State Justice nominees in a single round, with the bottom two vote-getters being eliminated. Citizen S.M. Huq 0450 from Stember County received the nomination for Chief Justice with 109 of the 451 votes cast.

Afterward, the convention proceeded to elect a nominee for State Comptroller, with Michael Bertlesman 0120 from McKnelly County receiving the nomination after a tight race that ended in a two-candidate runoff.
