Valesky discusses medical marijuana bill

MORRISVILLE – Senator David Valesky of the 53rd district of New York visited the Morrisville campus on Monday morning. Senator Valesky was in Boys' State in 1983, and has returned numerous years in the past.

Every year Senator Valesky tries to speak about a different subject. This year, he chose to teach the civilians of Boys' State how a bill changes as it goes through the process of becoming a law. The particular bill that Valesky chose was the Compassionate Care Act. This act, when it comes into effect, will make New York State the 23rd state in the union to legalize medicinal marijuana.

The first state to legalize medicinal marijuana was California. However, in Senator Valesky's opinion, the 1996 law passed in California was much too relaxed. Valesky stated that stated, "If we do it, we don't want to do it like California." For this reason, Valesky believed that the original bill in New York needed revision. The original bill, in Valesky's opinion, was also too loose. There was nothing in place to punish those who share their prescriptions with others, and also nothing to punish doctors who give prescriptions to people who do not need them.

The bill was revised, and according to Valesky, this law will be "the most restrictive of the 23 states." The Compassionate Care Act that Valesky is supporting will only allow 5 organizations

to produce the medicinal marijuana, and only 20 dispensaries throughout all of New York.

The law will not allow patients to smoke their prescription, and prescriptions will only be given out for

patients who have one of 9 diseases, such as cancer or HIV, where current medicine is not effective. This law will have a 7-year trial period, after which it will be reviewed and any necessary revisions will be made.

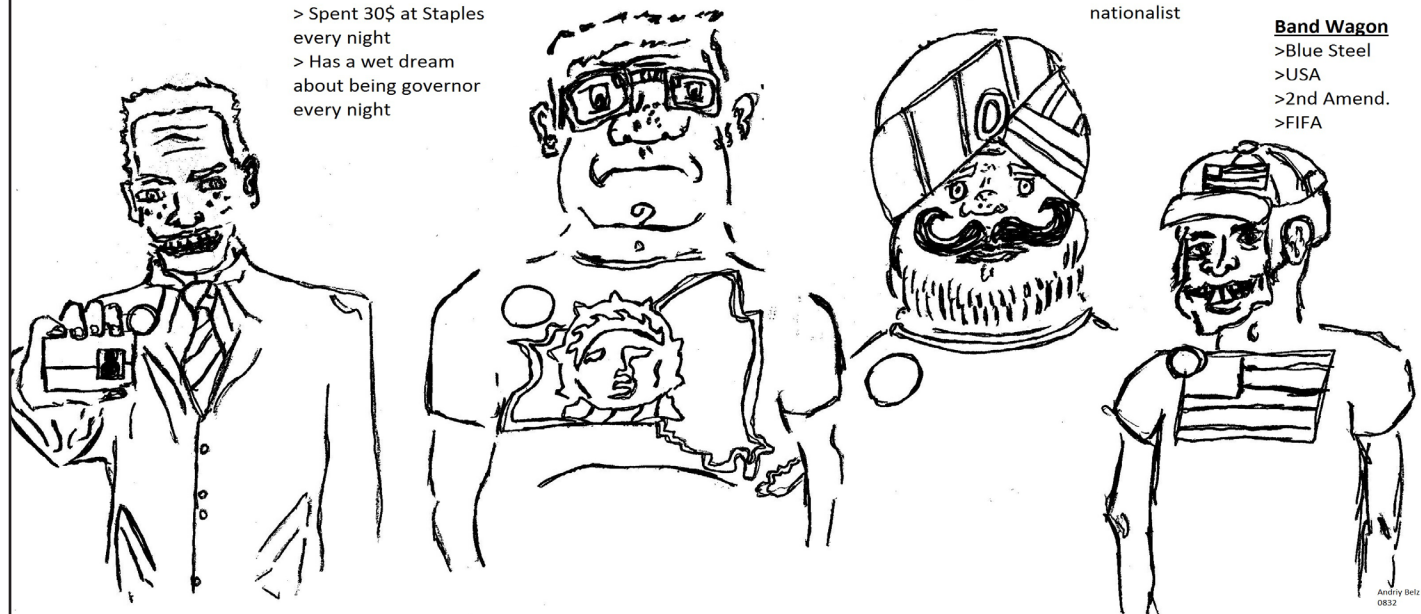

After the conclusion of the caucuses on Sunday, this reporter was able to sit down with the candidates for the position of Boys' State governor from both political parties. The purpose was to obtain information on the backgrounds of these candidates, giving the citizens' a clearer viewpoint of previous leadership and public speaking programs they were involved in, as well as personal interests, aspirations, and thoughts about the State Party Caucus.

The candidate from the Nationalist Party; Robert "Campbell" German 1011

of Koutz County, could only describe the way he felt as "beyond excited" and eager for the coming caucus. Robert hails from West Irondequoit, was student class president for 3 years, and runs an outside group dubbed National Youth Leadership Training. The Federalists wrap it up... with a slight delay

The final session of the Federalist Party Convention took place on Sunday evening, when the candidates for State Attorney General, Lieutenant Governor, and Governor were selected in a meeting that ran over 30 minutes over time.

The evening opened with several passionate speeches from the nominees for attorney general, which provided a welcome break from their repetitive predecessors. Nominees from Roosevelt, Stafford, and Scheiberling counties, albeit ultimately unsuccessful, seemed to move the crowd with their addresses, which received significant applause. The tight race concluded with a final one-on-one runoff in which the candidate from McKneely, Jonathan Jones 0212, defeated Anthony Kim 0518 from Stafford County by a vote of 231-215.

Unenthusiastic speeches returned to the forefront in the lieutenant governor's race, despite some notable exceptions from the nominees from Wong, Roosevelt, and Stember counties. In the second round Lucas Golan 0494 from Stember County, came close to achieving an absolute majority, but the second and third place finishers failed to withdraw, bringing the election to a third round. Golan was ultimately successful by a margin of 285 to 160 votes, defeating Joseph Lauria 0760 from Wong County and Benjamin Schafer 0394 from Fish County.

The gubernatorial race seemed to drag on, in some part due to the emer-

gence of the "Blue Steel" movement, which sought to unify the Federalist Party and seemed to get much attention in the nomination speeches of all gubernatorial candidates.

In the round of five candidates there was a tie for third place until the last minute, when a revision put the candidate from Pedro County, the incumbent permanent party chairman, in third place. Ultimately, the nod went

to the candidate from Pedro County, Ryan Leone 0194, who won acclaim and scorn from the audience for a speech that featured rapping. Leone captured the nomination with 240 of the 446 votes cast. This completed the slate of Federalist candidates running for statewide office, which also featured the seven nominees for Court of Appeals and the State Comptroller nominee Michael Bertelsman 0120.

The Nationalist Party platform

The Nationalist Party unveiled its platform on Sunday. The chairman who spoke was Andrew Zinner 0587. During the convention the Party unveiled many new proposals, but most outstanding of these were the dodge ball tournament, allowing Boys' State to watch the World Cup on Tuesday, and of course, integrating Boys' State and Girls' State.

The Nationalist Party started their speech with sports. They proposed Frisbee, flag football, and dodgeball. For dodgeball, they wish to hold a grand tournament with all the counties competing with each other. The winners would face the marines.

They talked about increasing taxes on the richest one percent of the country. They want to define business size based on net worth, not number of employees. Other important points they brought up were, rewards for businesses that use green energy, compen-

sations for using American labor, and using welfare as a tool for "those who need, not those who feed".

On the political side of things, the Nationalist Party favors stricter term limits on Assemblymen, Senators, and Governors. They also recommend there be a fixed budget of ten million dollars for state campaigns. They justify these reforms by citing the power that companies have to buy candidates and the corruption that comes with it.

The social aspect of the platform supports medicinal marijuana as a viable medical practice. They also favor a comprehensive psychiatric examination before buying a firearm. As for hydrofracking, they say it should be regulated by the state.

The four candidates for the Nationalist Party are Governor: Roger C. German 1011; Lieutenant Governor: Gerard Maraj 0951; Comptroller: Timothy Waddell 1005; Attorney General: Tennyson Bardwell 0639.

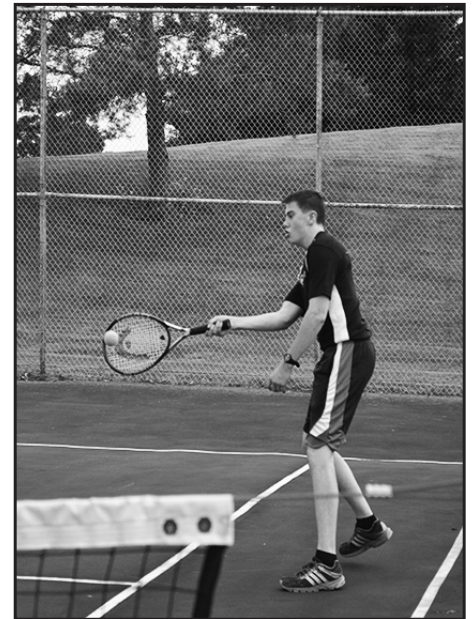
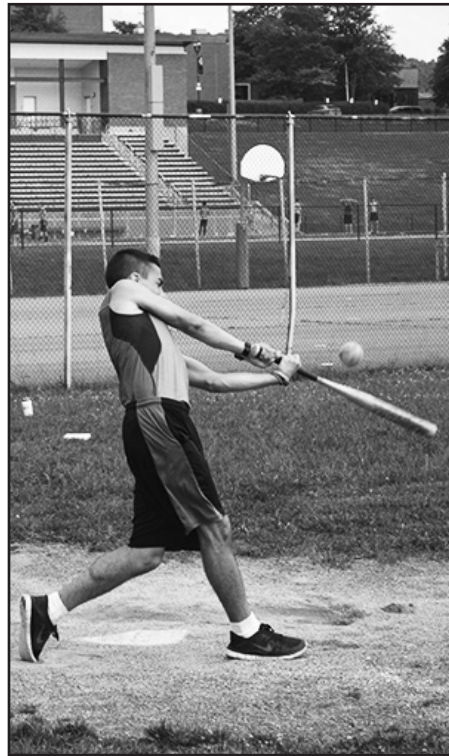

Are freshman college hoopsters going pro too early?

This past Thursday, the NBA hosted the college draft. Plenty of the top picks were freshman players leaving college early.

Players going pro after their freshman year college are nothing out of the ordinary: notable pro players like Anthony Davis and Carmelo Anthony went pro after their freshman years.

There are even players like LeBron James and Kobe Bryant who didn't even go to college before entering the draft. However, there has long been arguments on whether or not these college players going pro so early is more of an asset or a liability.

In 2012, journalist Marc Isenberg dove into why it can be a good or bad idea to leave school early as a basketball

player. Isenberg stated that players who leave college run the risk of sacrificing their education, and having no clear direction after their pro career concludes. He also stated that staying in college could allow the player to further grow mentally and emotionally before going pro.

However, Isenberg also made cases for leaving early. He argued that if the player is a first-round pick, his contract will guarantee millions of dollars. He noted the possibility of a freshman working off his degree in the offseason.

Either way you look at it; this is a thought-provoking topic. Unless the NBA acts to require two years in college, freshmen will continue go pro, prolonging a question that may not have a clear answer.
